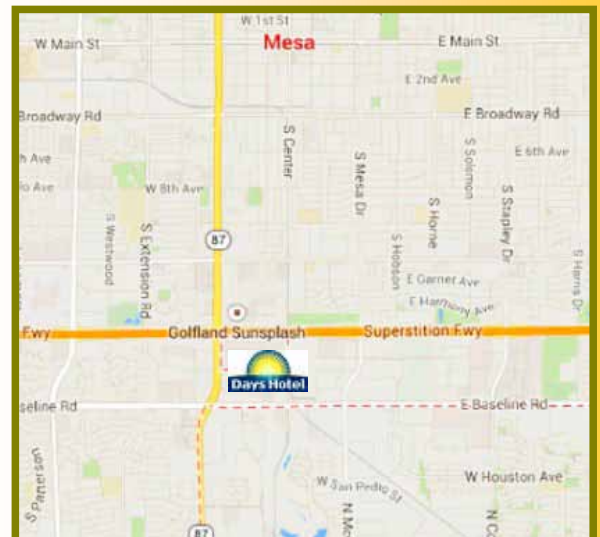

Pairings will be made at approximately 10:30 AM following the coaches' meeting; all coaches are urged to attend.

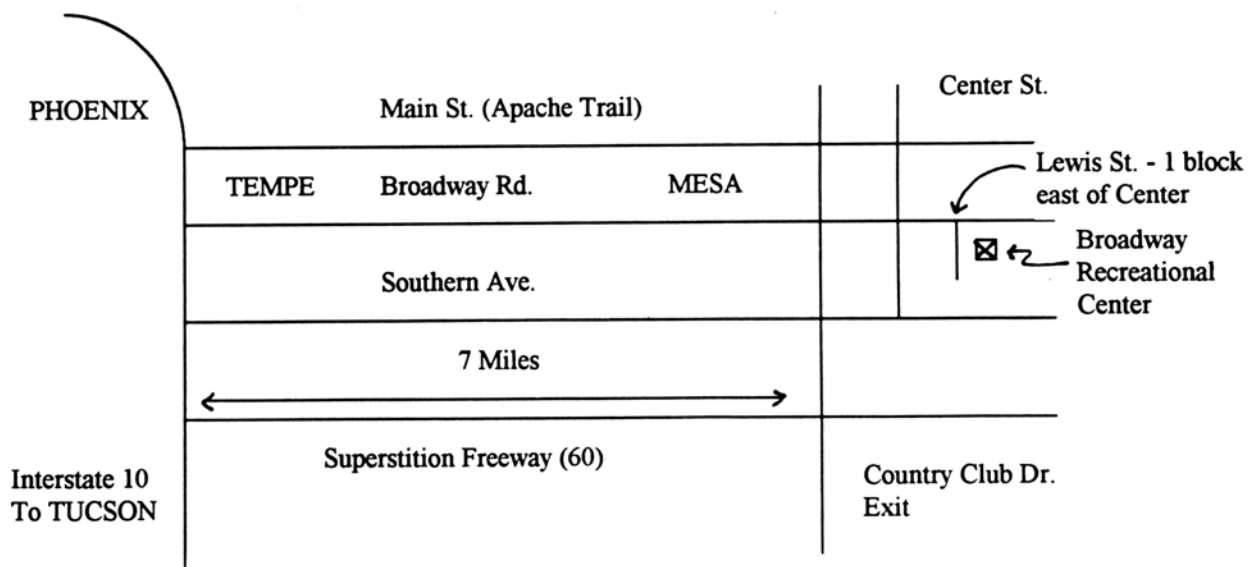
